### **Director Commitment and Expectations**

Thank you for your interest in becoming a Director on the board of the Bucks County Association of REALTORS®. It is important that you understand the commitment involved in being a Director, not only of time, but personal dedication to fulfilling the mission of the Association and representing the interests of all members and the real estate industry.

#### **Expectations of a Bucks County Association of REALTORS® Director:**

1. ***Attendance at all meetings of the Board of Directors.*** A calendar of meetings is established by September of the year prior to your term beginning. It is expected that Directors will place those meetings on their calendars at that time, to avoid conflicting obligations throughout the year. The meetings will last between one and two hours. The Board meeting must be a priority.
2. ***Attendance at all board leadership orientation and training programs, and completion of the BCAR Leadership Academy sometime within your term of office.***
3. ***Attendance and support of Association Programs and Seminars.*** Board members reflect the membership as a whole and should be highly visible through attendance at Association events.
4. ***Participation in a committee or Task Force.*** As part of the leadership of the association, it is expected that each Director will join committees, work groups and/or task force and, further, assume leadership roles within those groups.
5. ***Leave your office and franchise affiliation at the door.*** Issues discussed and decisions made are made for the good of all. As a Director you represent all BCAR members.
6. ***Be familiar with all the issues presented at a directors' meeting and be prepared to contribute to the discussion.*** Any material sent to you prior to a meeting must be reviewed ahead of time. It is also expected that each Director will be fully engaged at and contribute to all meetings.
7. ***Willingness to be a representative of the Association*** at community functions, state meetings, contiguous Association meetings, or other meetings of importance to the Association.
8. ***Able to make a commitment for the term of office for which you are running.*** The full term is three years. Vacancy terms are for the remaining term of the vacant director position.
9. ***Asked as a Director to set an example*** by making a voluntary investment of at least \$99.00 in RPAC (Realtors® Political Action Committee). In addition, as leaders of the association Directors must educate themselves about RPAC – its purpose and its impact within BCAR and beyond.
